 - (2) Jeff Vickers made a motion to recommend to the Board of Supervisors the conditional approval for the Popeye's & Wendy's Land Development Plan, subject to the following: satisfaction of any outstanding items in Great Valley's review letters, modification of the Wendy's loading space design, adding truck traffic signage and incorporating comments on the Land Development Plan. Allen Styer seconded the motion. Motion carried unanimously.
