- I. Fish and Game Commission Social Hall Request Keith Fritz made a motion to approve the presented PA Fish and Boat Social Hall Request. Jeff Vickers seconded the motion. Motion carried unanimously.
- J. Public Works Items
 - (1) Swamp Road Pipe Work Estimates Paul Whiteman, Jr. made a motion to approve the Tri County Landscape Creations, LLC estimate in the amount of \$3,882.00 for the 371 Swamp Road driveway pipe work. Keith Fritz seconded the motion. Motion carried unanimously;
 - (2) Settler's Trail Pipe Work Proposal Road Foreman McGowan discussed pipe work needed in the area of Settler's Trail, all work to be done in house. After discussion, Paul Whiteman, Jr. made a motion to approve the in house pipe work for the Settler's Trail project. Keith Fritz seconded the motion. Motion carried unanimously;
 - (3) Guiwell Proposal for Heating and Air Conditioning Maintenance Services Road Foreman McGowan discussed HVAC preventative maintenance requirements. After discussion, Paul Whiteman, Jr. made a motion to approve the presented Guiwell quote in the amount of \$3,840.00. Jeff Vickers seconded the motion. Motion carried unanimously;
 - (4) EM Kutz Equipment Install Quote Keith Fritz made a motion to approve the EM Kutz, Inc. equipment quote for the 2022 Pick-Up, in the amount of \$2,418.00. Jeff Vickers seconded the motion. Motion carried unanimously;
 - (5) Park Fencing Repairs Road Foreman McGowan discussed Park Fencing repairs needed, including handrail installation work. After discussion, Paul Whiteman, Jr. made a motion to approve the estimated \$3,000.00 Park Fencing repair work. Keith Fritz seconded the motion. Motion carried unanimously.
- K. Sewer Authority Appointment Paul Whiteman, Jr. made a motion to approve Resolution No. 2022-51, Sewer Authority Appointment. Keith Fritz seconded the motion. Motion carried unanimously.
- L. Street Obstructions Sample Ordinances The Board requested that Road Foreman McGowan compile a list of recommended items to be regulated. Compiled list will aid in formulating a street obstructions Ordinance.
- M. EZ Pass Application Michelle Raymond, Lenape Drive, inquired about purpose of purchasing EZ passes. After discussion, Jeff Vickers made a motion to approve purchasing Township EZ Pass transponders, reserve amount of \$100.00, and Administrator Joan Bair as signer on the application. Keith Fritz seconded the motion. Motion carried unanimously.
- N. Zoning Hearing Board Application The Board reviewed a Zoning Hearing Board application for the Morgantown Crossings Center (Wendy's sign), the Hearing is scheduled for November 10, 2022.
